2024 INFORMATION AND REQUIREMENTS FOR SPONSORING A CANDIDATE FOR MEMBERSHIP

Sponsor Requirements per Bylaws Article IV, Sections 4.02 B and 4.03-4.05

Active and Non-Resident Member Qualifications

- Must be an active/non-resident member in good standing. May sponsor one candidate per fiscal year (i.e. April 1 – March 31). Sponsor must have shown financial and/or volunteer participation in JCB for at least three years.

Honorary Member Qualifications

- May sponsor one candidate per fiscal year.

Life Member Qualifications

- May sponsor one candidate per fiscal year; however, once a Life Member's candidate has been accepted for membership, the Life Member **may not** sponsor a subsequent candidate.

To Sponsor a Candidate:

- Attend a **mandatory** sponsor meeting on Tuesday, **April 2, 2024** from 1:30-2:30 p.m. or Wednesday, **April 3, 2024** from 2:00-3:00 p.m.;
- Go online or pick up Sponsorship Form at the Jewel Charity office. Sponsor must provide one copy of the form, including a photograph of the candidate to the Jewel Charity office no later than 5 pm on **April 19, 2024**;
- Sign up for a time to meet **in person** with the Membership Committee for Membership Interviews on Tuesday, **April 30, 2024** or Wednesday, **May 1, 2024**. Link is on the Jewel Charity website under the Members tab.

Requirements for Candidates for Membership per Bylaws Article IV, Section 4.01 A

- Candidate must have lived within a 50 mile radius of Cook Children's Medical Center for two years preceding nomination;
- EACH candidate must be 30 years of age prior to April 1, 2024;
- Candidate must have demonstrated sustained support for the mission of Jewel Charity and/or Cook Children's through financial and/or volunteer participation for at least three years prior to nomination.

New Member Responsibilities per Bylaws Article IV, Section 4.02 E

- \$2,100 Membership Dues, paid in full within seven (7) days of the receipt of invitation to membership;
- Minimum Silver Angel level donation (\$3,000) by January 31, 2025;
- Purchase or Sale of a minimum of \$2,000 in Raffle Tickets (outside of events) to family and friends to be completed 14 days before the Ball;
- Attend New Member Orientation meeting August 29th, 2024, at Cook Children's Medical Center, Decker Board Room, at 5:30 p.m.;
- Attend Jewel Charity Ball and sell Raffle Tickets;
- Sell Raffle Tickets at Men's and Ladies' Events;
- Complete a minimum of 20 mandatory volunteer hours of service;
- New Members failing to meet these requirements shall be deemed to have resigned.
